

# 2023 GOLD COAST CAR SHOW

## EVENT PARTICIPATION WAIVER, RELEASE & ACKNOWLEDGEMENT AGREEMENT

**IMPORTANT NOTE:** This is a legal document binding upon the parties. You should read carefully and sign at the bottom of the page which signifies that you have read it, understand it and agree to comply with it.

This agreement relates to the Gold Coast Show on the 21<sup>st</sup> & 22<sup>nd</sup> October 2023 at the Mudgeeraba Showgrounds QLD 4213. The Event Promotor is Kevin Franklin (PO BOX 323, Broadbeach, QLD 4218) and the Event Coordinator is Kathryn Franklin (PO BOX 323, Broadbeach, QLD 4218)

I acknowledge the opportunity to participate at the Gold Coast Car Show at any time between the dates of 12th October 2023 until the 23<sup>rd</sup> of October 2023 either as a Volunteer, or an Employee, or a Trade Exhibitor or a Food Vendor or a Charity Organization or a Product Supplier or a Community Organization or a Performer/Act or Band is subject to the following terms and conditions;

1. I agree to follow promptly and diligently all the instructions given, by either the Promotor or the Event Organizers' and Event Staff Team during the Show;
2. I agree that any images taken during the participation in the event may be used by the Promotor for promotional purposes and the copy right of these images owned by the Promotor. I will not claim any remuneration because of the Promotor using my name, images, voice in media, for any period the Promotor deems required for the promotional purpose;
3. I accept all risks associated with participating in the Gold Coast Car Show Event including prior to set up or during operating hours of the event and pack down of the event if my services are required;
4. I consent to receive any medical treatment such as first aid, that the Promotor or Event Organizer, or any event management staff consider necessary during or after the event;
5. Subject to any liability which cannot be excluded by law, I agree that the Promotor, The Event Coordinator, Organizer, Suppliers and Contractors, are not responsible for any claims in relation to personal injury, death or damage to property that I may suffer directly or indirectly whether it arises from my negligence or otherwise in connection with my participation in the event;
6. Subject to any limitations imposed by law, I indemnify the Promotor and the Event Organizer against any loss, claim (including third part claims), liability, expenses (including legal and associated expenses) or damages of any nature or description whatsoever (regardless of whether caused by any acts or omission on the part of Promotor or Event Organizer or their staff) suffered by the promotor or the event Organizer either directly or indirectly as a result in the participation of the event;
7. If you are under 18 years of age at the time of entering the event, the declaration of accepting the terms of entry must be accepted by your parent or guardian. You agree that your participation will be supervised continuously by an adult throughout the event. Failure to do so will result in your entry being declared void;
